TERMS & CONDITIONS

- 👑 ALL BOOTHS MUST BE SET UP BY 10:00 A.M. Failure to appear one hour before the official start of the event may result in forfeiture of your booth space.
- 👑 LOAD IN TIME IS BETWEEN 7:30 - 9:30 A.M. everyone must load in during this time and all vehicles must be parked in a designated lot by 9:45 a.m.
- 👑 You are responsible for bringing all equipment (display cases, racks, shelves, etc. indicated and approved on the application) beyond what is provided by the Mid-City Bayou Boogaloo Festival.
- 👑 Displays, decorations and items to be sold should not extended beyond the dimensions of the booth space.
- 👑 The Mid-City Bayou Boogaloo and its producers are not responsible for your booth belongings and will not supervise your booth in your absence. YOUR ORGANIZATION IS RESPONSIBLE FOR BRINGING AMPLE ASSISTANCE FOR YOUR BOOTH.
- 👑 exhibitors are required to bring their own cart or dolly if needed. THE FESTIVAL CANNOT PROVIDE DOLLIES OR CARTS FOR YOU ON THE DAY OF THE FESTIVAL.
- 👑 Be prepared for the potential for rain and large crowds by securing items within the booth space
- 👑 BOOTHS MUST REMAIN OPEN AND STAFFED FROM 10:00 A.M. THROUGH 4:00 P.M. Be sure to bring enough materials for distribution throughout the entire day.
- 👑 Clean booth area and remove ALL waste to appropriate recycling or disposal receptacles. Recycled items such as boxes must be broken down and taken to bins in parking lot.
- 👑 Remove all personal equipment, and please contact the Community Groups Coordinator before departing the festival grounds.
